## PRECAUTIONARY MEASURES AGAINST THE CORONAVIRUS DISEASE ("COVID-19")

In line with the Government's directive and Securities Commission Malaysia's revised Guidance Note on the Conduct of General Meetings for Listed Issuers (SC Guidance) to curb the spread of COVID-19, the 10<sup>th</sup> AGM of the Company will be conducted on a virtual basis through live streaming and online voting via Remote Participation and ("RPV") Voting facilities. Pursuant to the SC Guidance, all meeting participants including the Chairman of the Meeting, board members, senior management and shareholders are to participate in the meeting online.

Due to constant evolving COVID-19 situation in Malaysia, we may be required to change the arrangements of our 10<sup>th</sup> AGM at short notice. Kindly check the Company's website or announcements for the latest updates on the status of the 10<sup>th</sup> AGM.

The Company will continue to observe the guidelines issued by the Ministry of Health and will take all relevant precautionary measures as advised.

#### ENTITLEMENT TO PARTICIPATE AND APPOINTMENT OF PROXY

Only members whose name appear on the Record of Depositors as at 24 August 2021 shall be eligible to attend, speak and vote at the 10<sup>th</sup> AGM or appoint proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.

In view that the 10<sup>th</sup> AGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Proxy Form.

If you wish to participate in the 10<sup>th</sup> AGM yourself, please do not submit any Proxy Form for the 10<sup>th</sup> AGM. You will not be allowed to participate in the 10<sup>th</sup> AGM together with a proxy appointed by you.

Shareholders or proxy(ies) or corporate representative(s) or attorney(s) can proceed to vote on the resolutions at any time from 9.30 a.m. on **Wednesday**, **1 September 2021** but before the end of the voting session which will be announced by the Chairman of the meeting. Please refer to the

Upon completion of the voting session for the AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
